

# The journey to a pitch-perfect finish

While comparisons are inevitable, in this case "life imitating art", the real feeling of the reel, the Indian women hockey team's "Chak De" of Australia in the quarter finals of the Olympics is a good time to pause and reflect on all that has happened. If the men's dismissal of Great Britain — what with the buildup involving a full-on invoking of the colonial past — was fist-pumping passion and confirmation that, yes, maybe #ItsComingHome, the women's response to that has been significantly bigger. In scale, shock value, achievement, astonishment and everything in between.

Human beings play sports, but confirmation of success in this information age is always linked to statistics. The Indian women were ranked 12 (having dropped three places after three consecutive losses in the group stage) when they went into their match against Australia, the World's second best team. Australia had conceded one goal throughout the group stage, in their opener against Spain, and scored 13 through it. India, meanwhile, scored seven and conceded twice as many. Australia were the favourite for the knockouts, but as the Indian team's coach, Sjoerd Marjine, had emphasised in the match's build-up, after those three losses, India had been in a knockout tournament every game. And when it mattered, they delivered, scoring essentially just that one goal more than their opponent each time they had their backs to the wall.

For women's hockey in the country, this result may well turn out to be a watershed moment, one that takes this team from a feel-good story — something that is in equal parts patronising and condescending to such talented, hard-working elite athletes — to one where more is demanded, aspired for

and provided for, too. While the faults of national sports federations in India need magnification all the time, Hockey India has done what many others have failed to for a long while — give equal funding to teams of both sexes in preparation for the Olympics.

In 2018, the government of Odisha entered into an agree-

ment with the federation to sponsor both teams for five years. While the exact sponsorship amount has never been released officially, it is estimated to be around ₹150 crore. Both teams were also sponsored under the TOPS scheme, which guaranteed players a ₹50,000 per month allowance till the Olympics. For onlookers, this may not seem as important as wearing the national colours at the Olympic stage, but it is exactly the safety net most athletes desire and need to achieve success.

As professional sport disin-

tegrated into home workouts in isolation last year, the federation locked probables of both squads at the Sports Authority of India centre in Bengaluru, a high-performance complex with world-class playing facilities and housing. For a majority of the year, they have been separated from their families, allowed to return for a short while. Even in that time, online sessions were maintained.

The word "family" features heavily in conversation with any member of the team. And at the forefront of turning them into one has been Marjine. This is a coach who has suffered hugely over the past few years. In 2018, despite doing some great things with the women's team, he was shifted to the men's team. After a short stint, which saw him oversee a disastrous Commonwealth Games campaign, he was promptly brought back to the women. Most would've considered it a demotion and walked away (a few others have) but Marjine didn't want to leave his girls in the first place. This was *his* team. He will leave this job at the end of the Olympics to get back to his family who he has seen for a mere few weeks in over two years. But for now, his tweet from the team bus, a selfie with the entire squad beaming in the background, says it all: "Sorry family, I [am] coming later."

## Narrow miss for discus thrower

Tokyo, 2 August

Discus thrower Kamalpreet Kaur finished a creditable sixth in her first Olympics with a best throw of 63.70m in a rain-interrupted final on a day the women's hockey team won hearts to enter their first-ever semi-final and reaffirm the resurgence of India's national sport.

The 25-year-old Kaur, who qualified for the final as second best on Saturday, was never in the running for a medal in the eight rounds of competition that saw rain for more than an hour.

She had a third round throw of

63.70m to end at sixth and equal 2010 Commonwealth Games gold medalist Krishna Poonia's performance in the 2012 London Olympics.

Throughout the competition, Kaur, who was without her personal coach, looked nervous and short of confidence as she lacked international exposure.

The farmer's daughter from Punjab's Kabarwala village had raised hopes of India's elusive athletics medal after finishing second in the qualification round on Saturday with a best throw of 64m.

American Valarie Allman took the gold with a first round throw of 68.98m while Kristin Pudenz (66.86m) of Germany and reigning world champion

Yaime Perez (65.72m) of Cuba won the silver and bronze respectively.

Star sprinter Dutee Chand continued her disappointing run in Tokyo as she failed to qualify for the women's 200m semifinals after finishing last in her heat.

She registered a season's best timing of 23.85 seconds to finish seventh and last in her heat. Chand, who has a personal best of 23 seconds, ended 38th

overall out of 41 competitors. On Friday, she failed to progress to the semifinals of the women's 100m event as well.

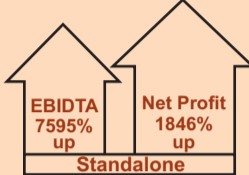
Shooters Aishwary Prapat Singh Tomar and Sanjeev Rajput failed to qualify for the finals of the men's 50m rifle 3 positions event.

Tomar finished 21st in the qualification while Rajput was placed 32nd at the Asaka Shooting Range as the Indian shooting team returned without a medal for the second straight time at the Olympics.

Equestrian Fouaad Mirza, meanwhile, finished a respectable 23rd in eventing after he became the first Indian to reach the final of the event. Mirza and his equine Seigneur Medicott sneaked into the top-25 in the morning to make the jumping finals.

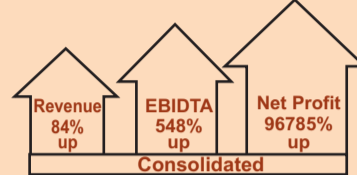
